

S&P 500 index and GLC's Tech Services coverage indices over the last twelve months





GLC's Commercial IT coverage indices by geography over the last twelve months








Public company valuation trends across Tech Services sector categories for the last twelve months




M&A Transaction Volume Contribution by Geography

European IT Services M&A Activity


Quarterly M&A volume and total reported enterprise value since Q1'2020






Senior Cash Flow Loan Pricing





Rate and Issuance Tracking




SOFR vs Trailing IT Services Composite Multiples


