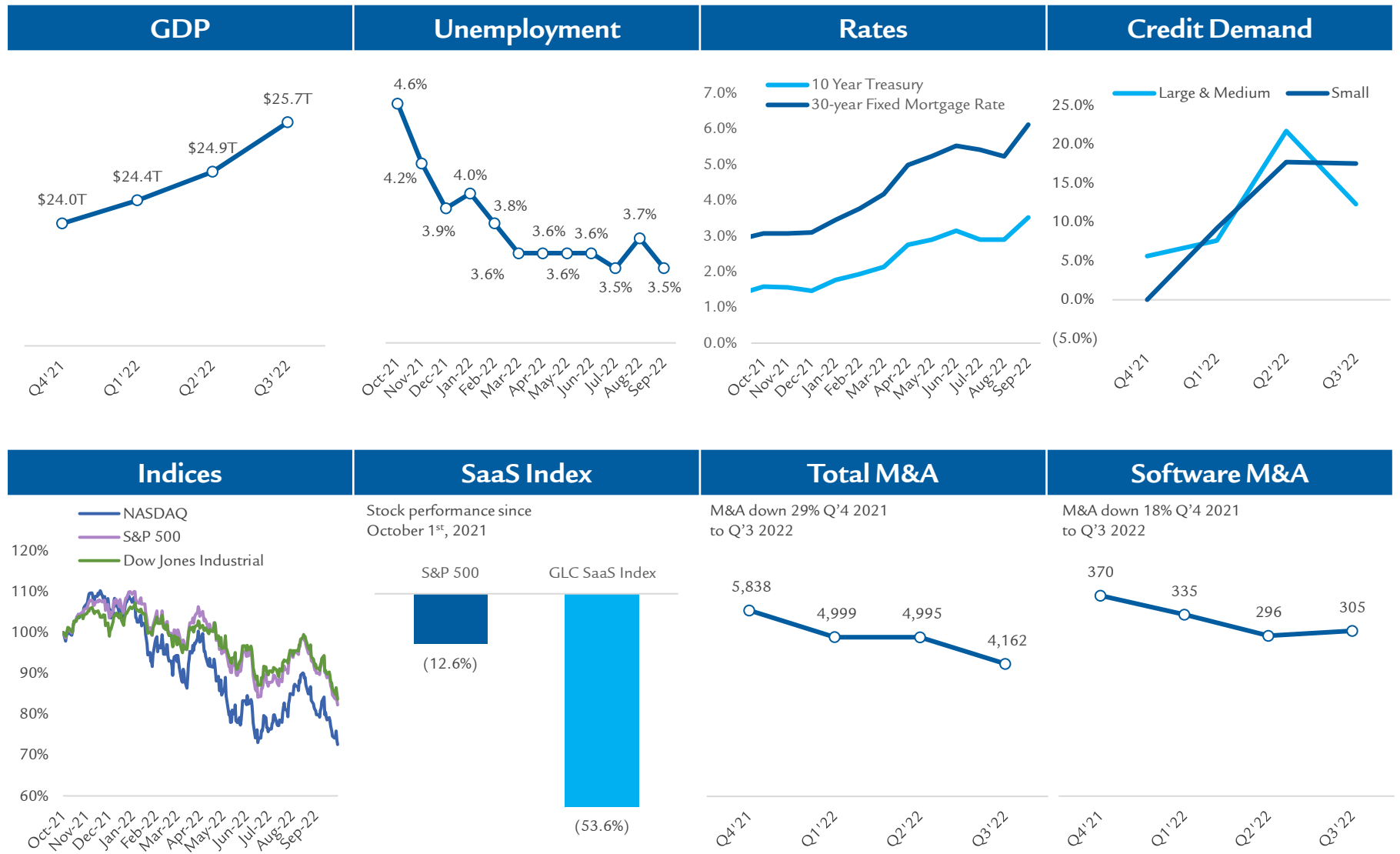

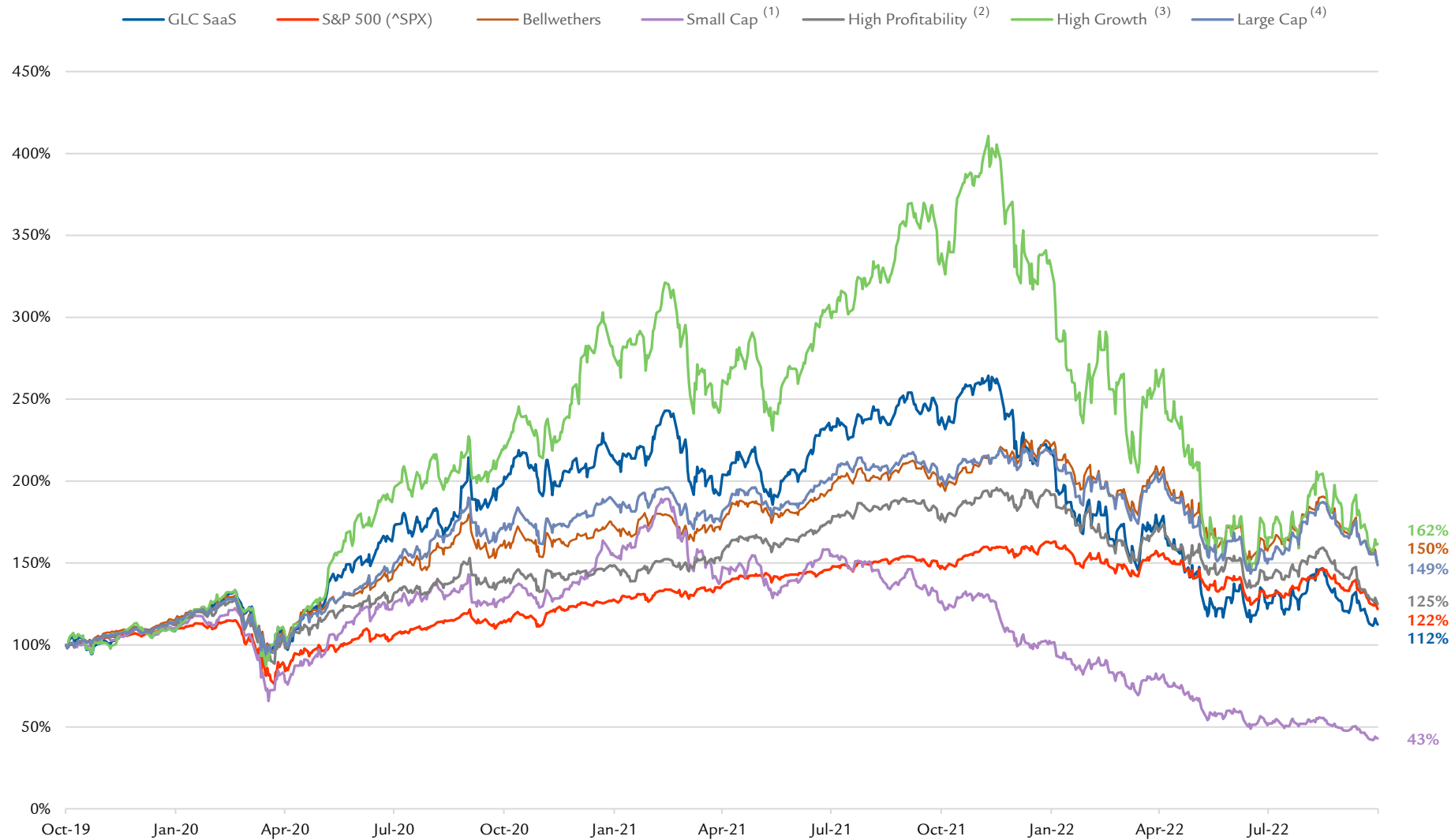

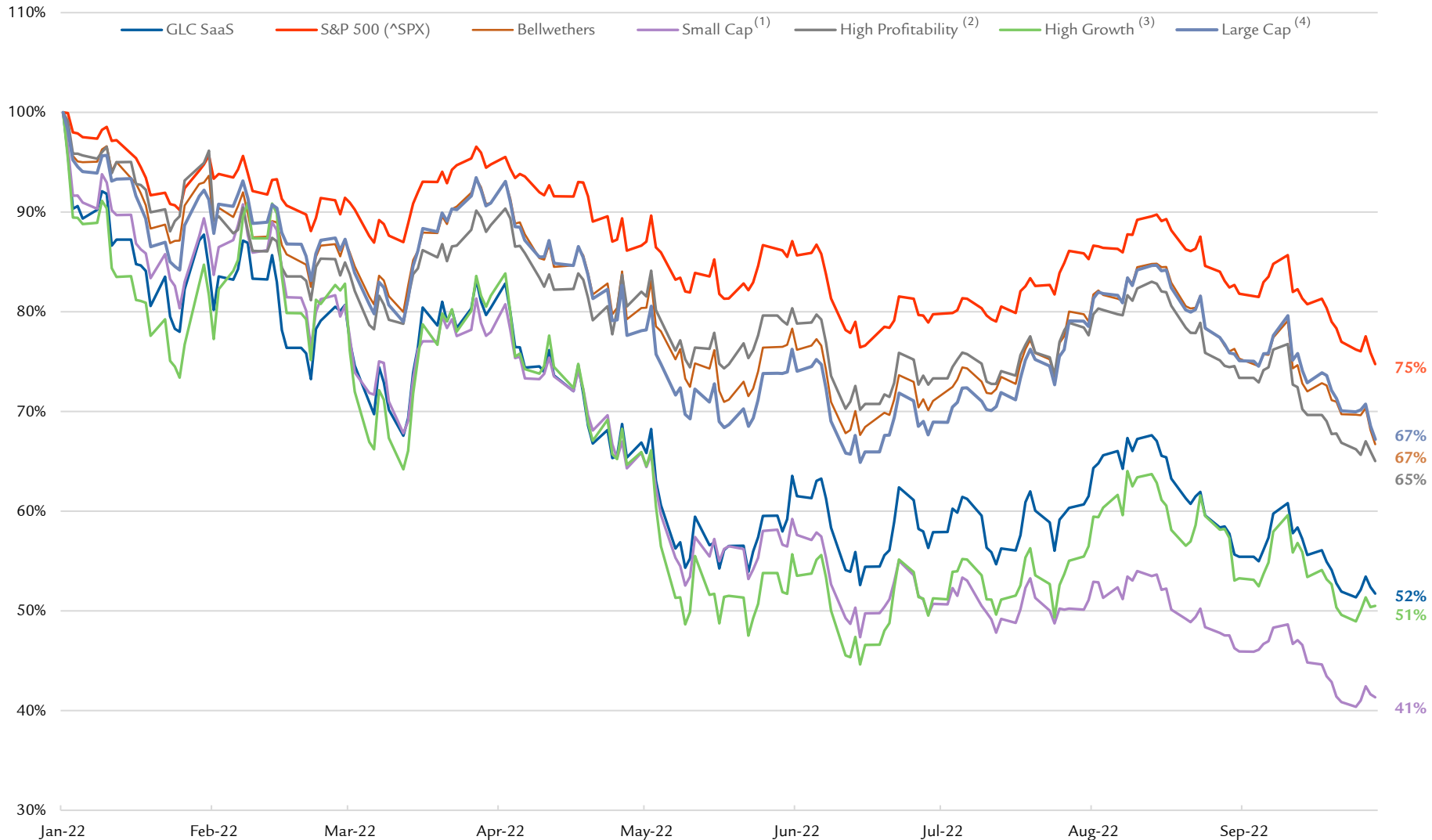
Software Public Equity Market Trends: Last 3-Year Performance

Broad public market indices and GLC's technology coverage indices over the last 3 years



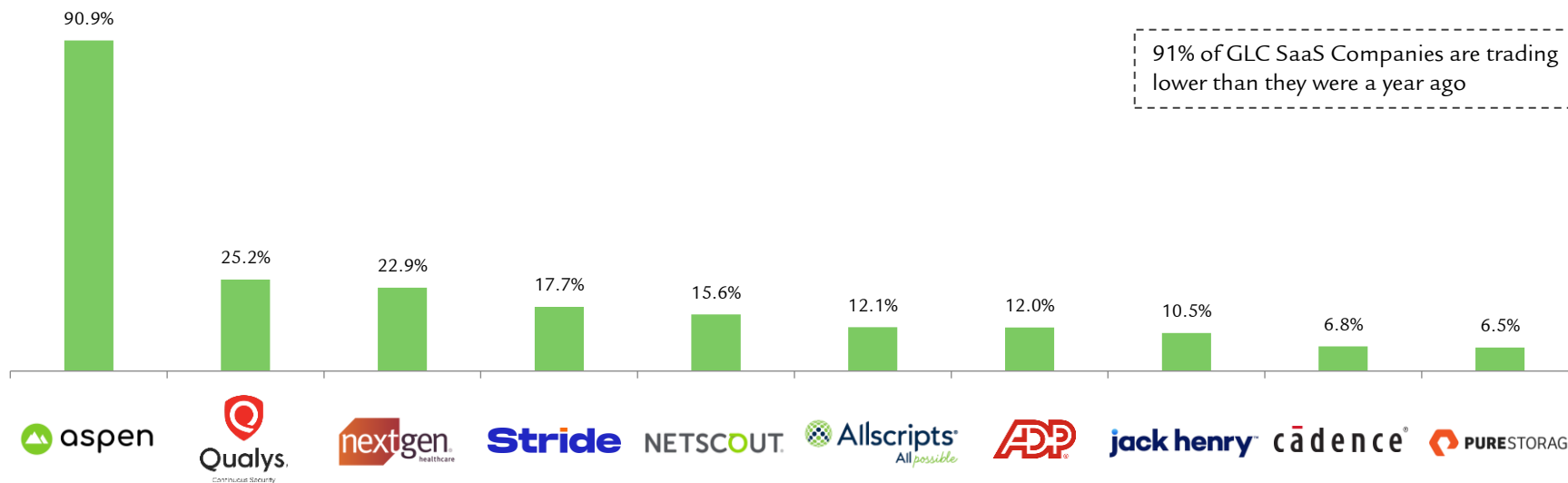
Public Software Equity Markets: Year to Date Performance

January 1st – September 30th, 2022, relative software performance

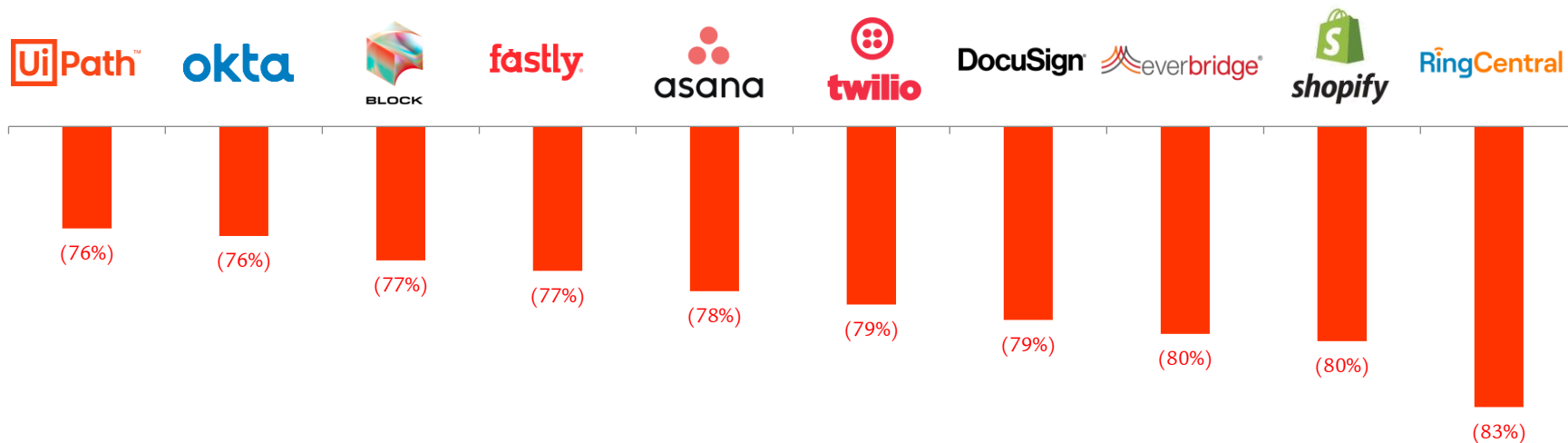

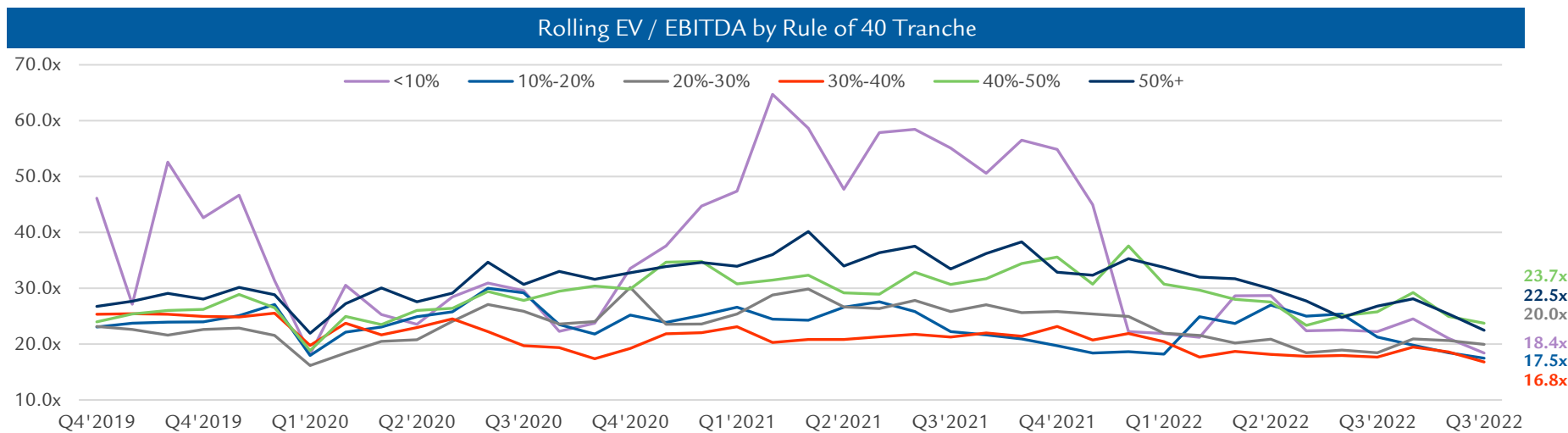
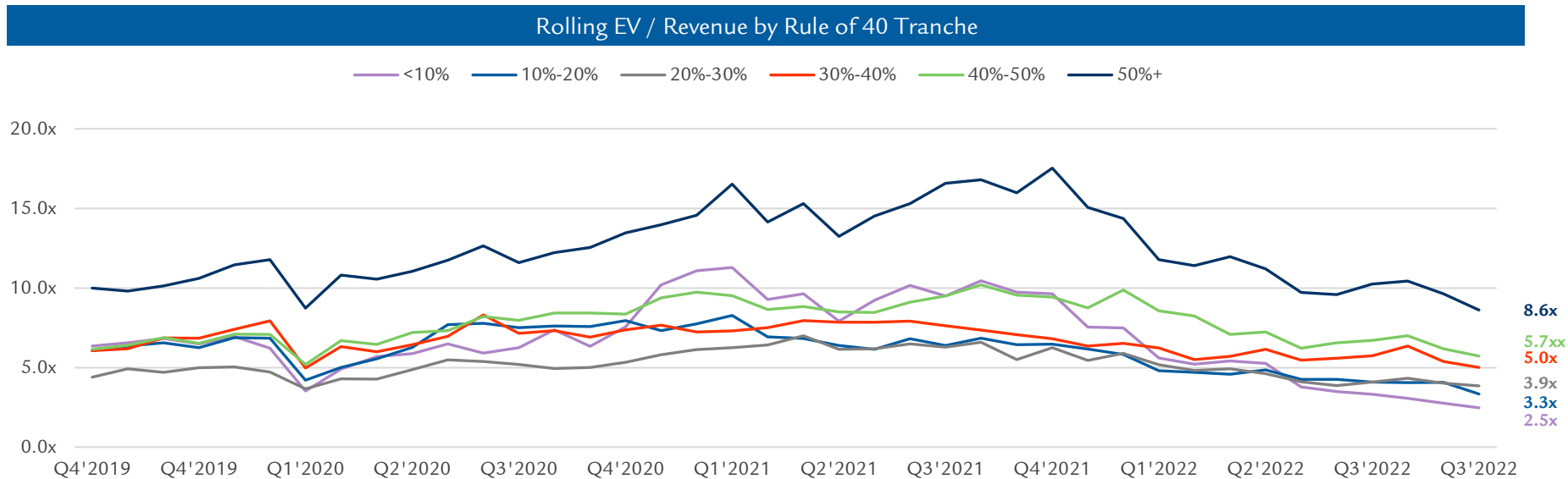

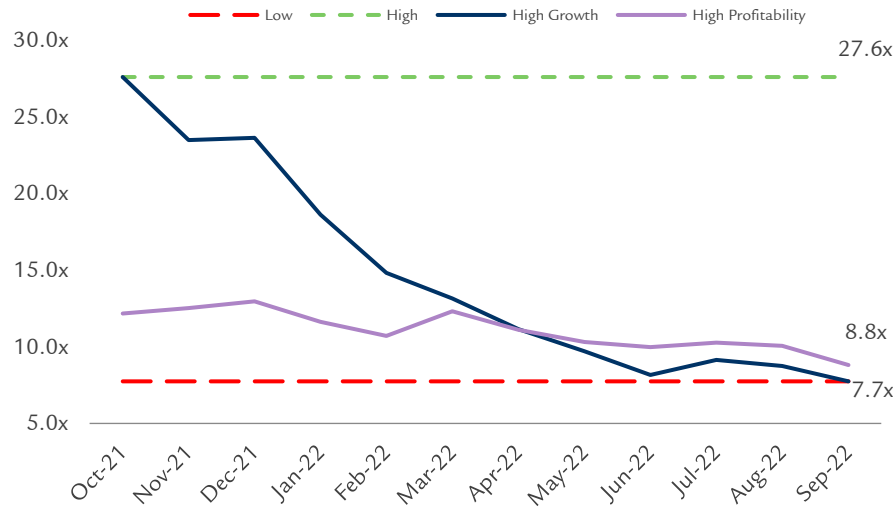
Software Public Equity Market Trends: Rule of 40 Performance

Rule of 40 relative to public company software trading multiples for the last twelve months

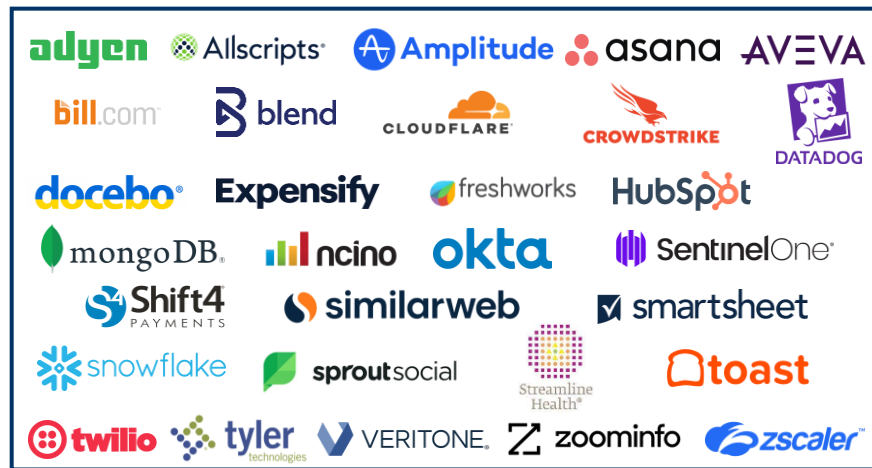

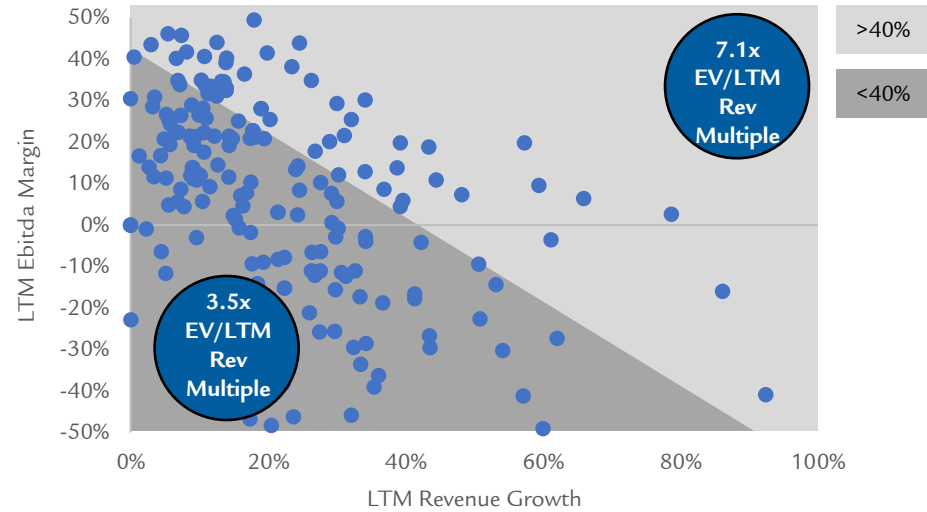
High Growth vs High Profit Software Companies Rolling Med. EV/LTM Revenue

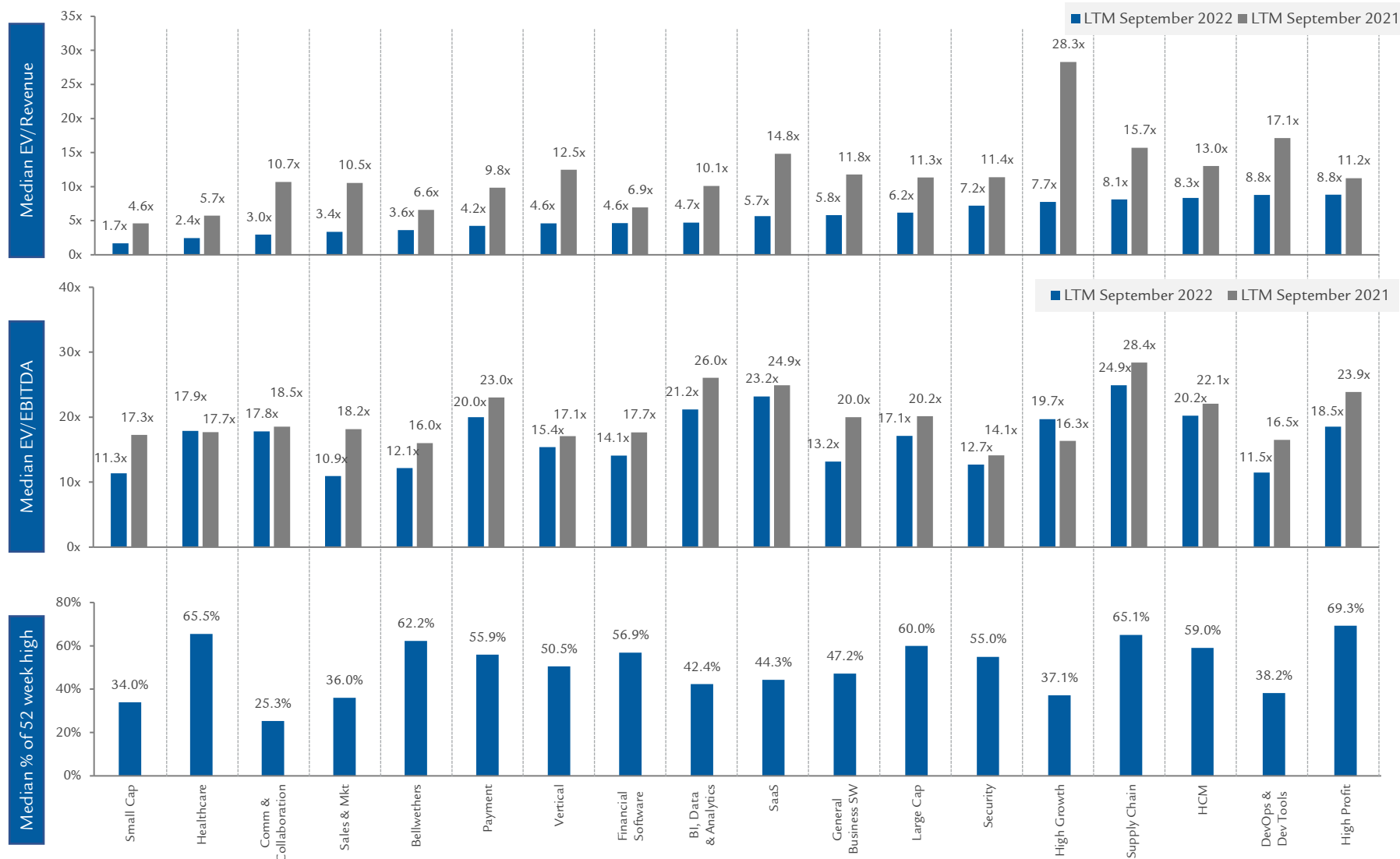

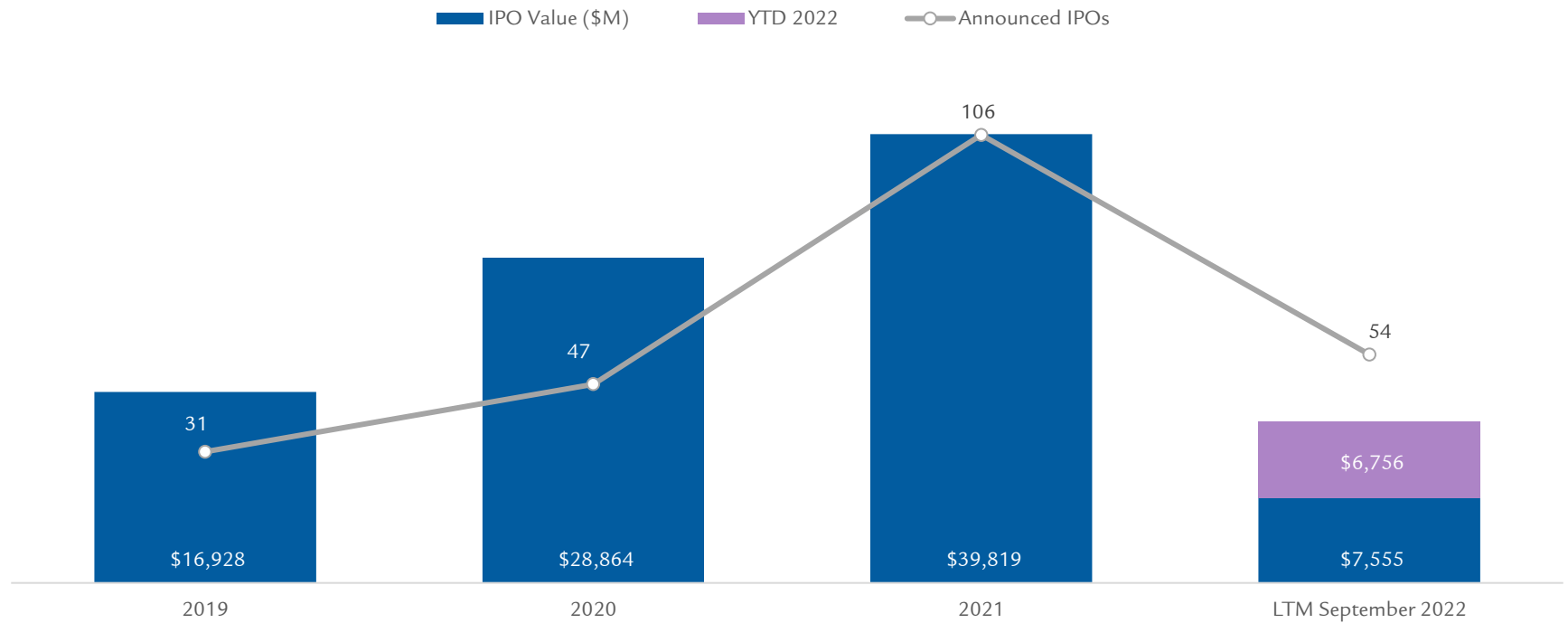

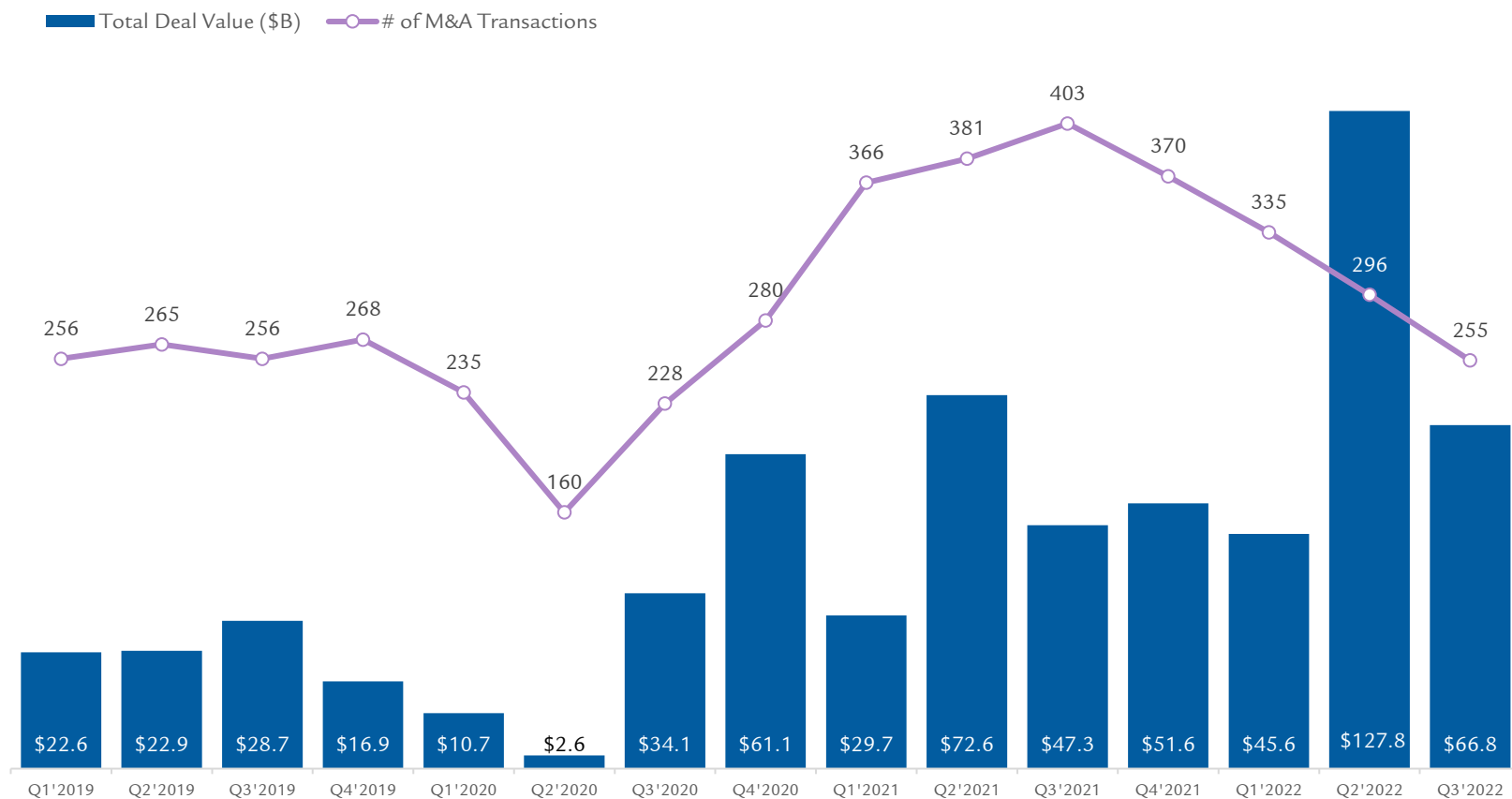

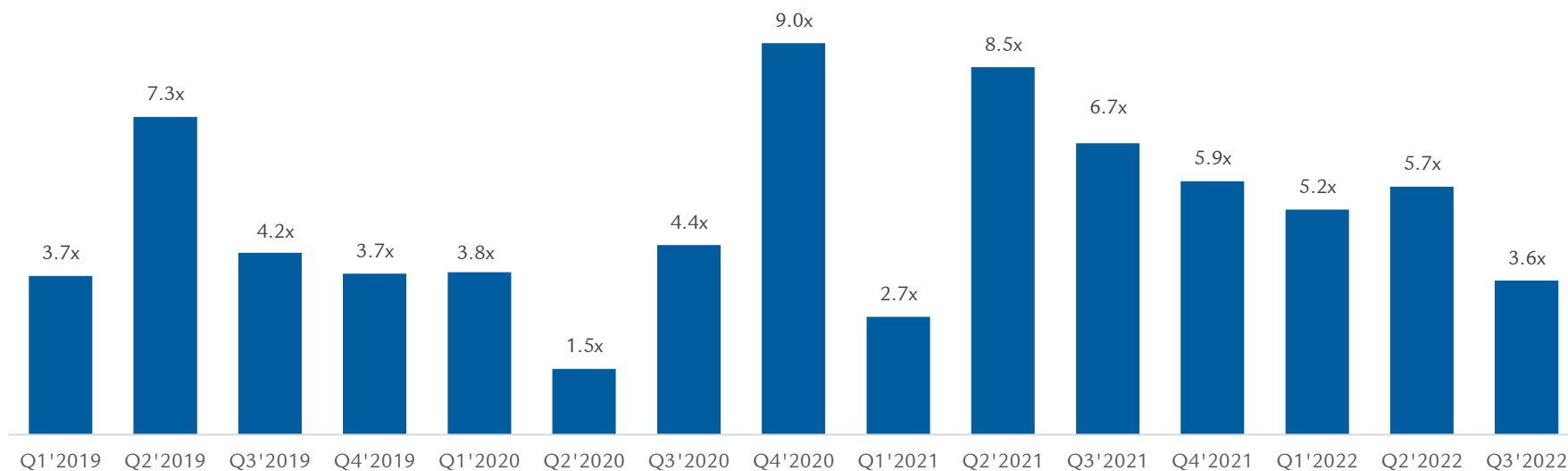

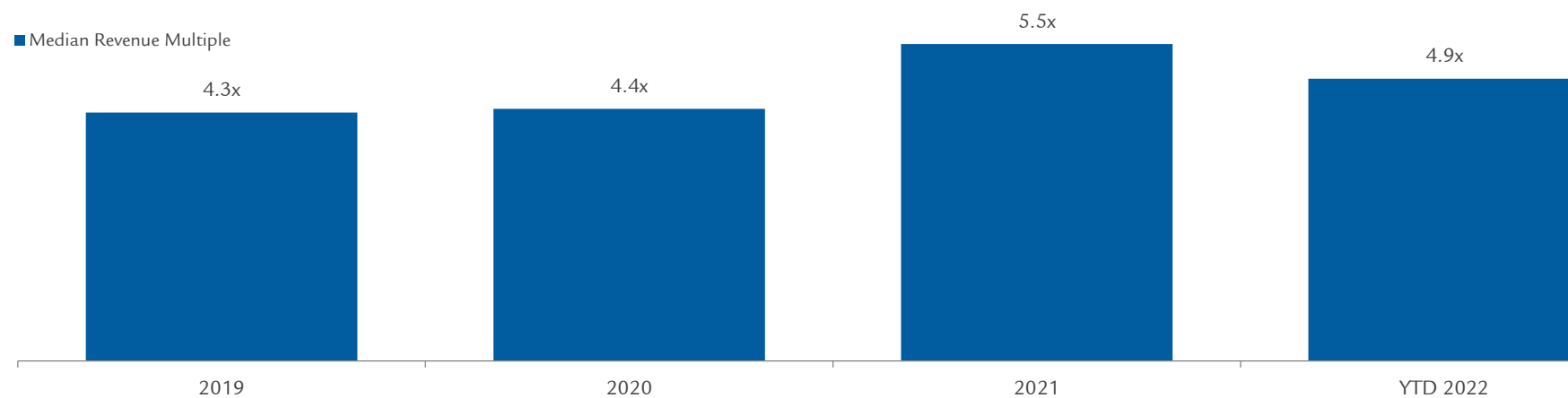

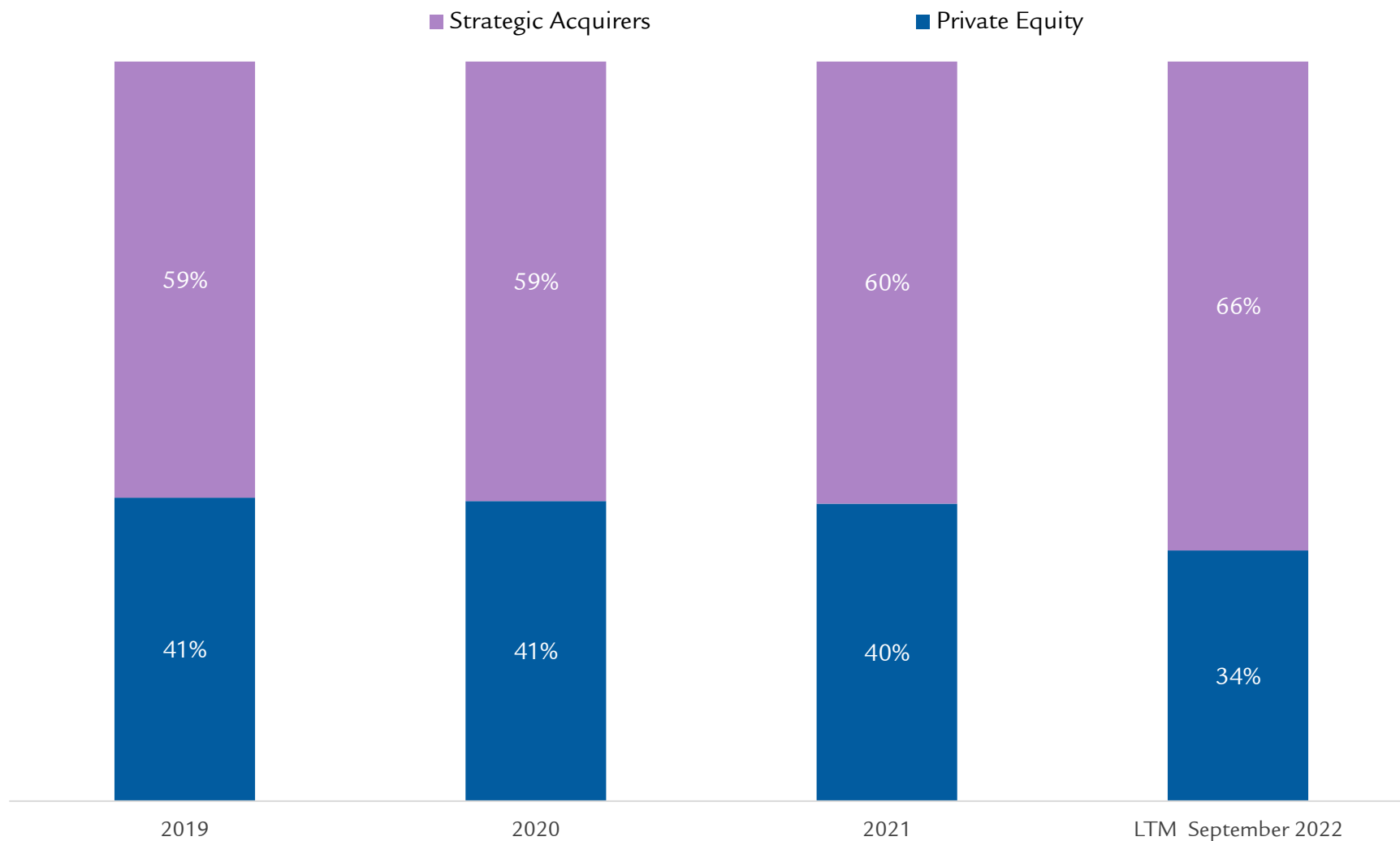

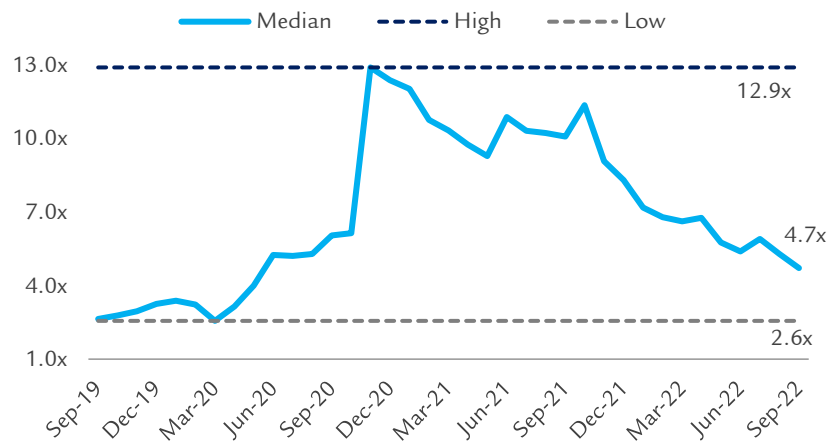
Bellwethers 3-Yr Rolling Med. EV/LTM Revenue

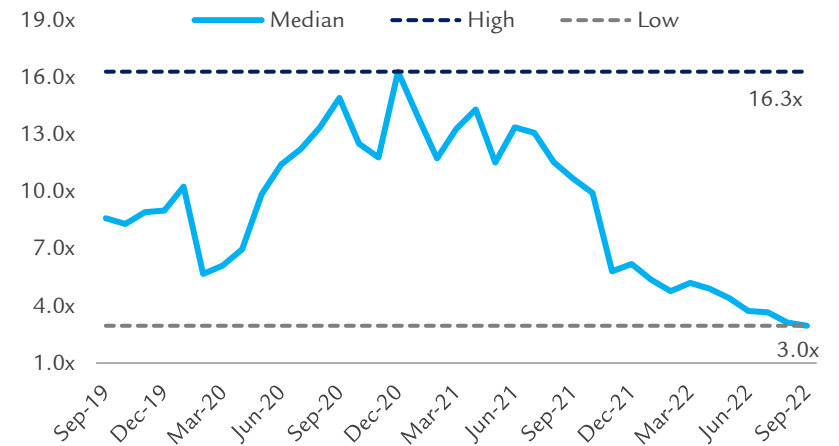

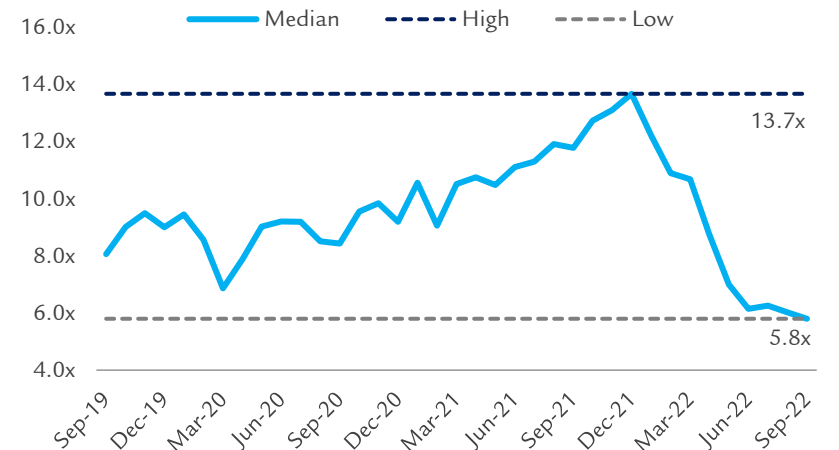
Comm & Collab 3-Yr Rolling Med. EV/LTM Revenue

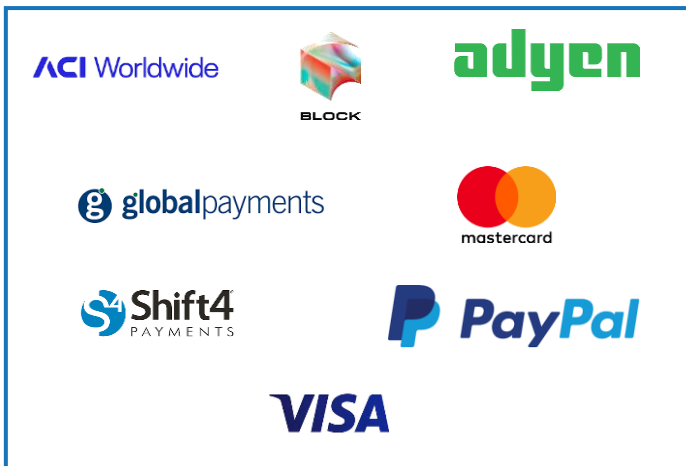
General Business Software 3-Yr Rolling Med. EV/LTM Revenue



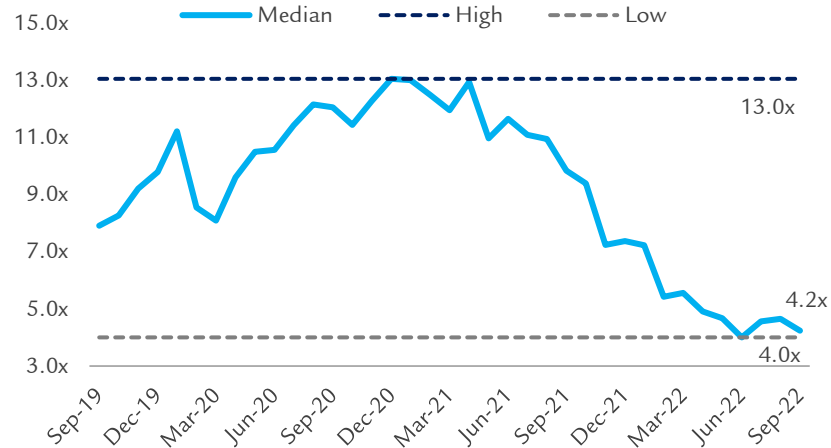

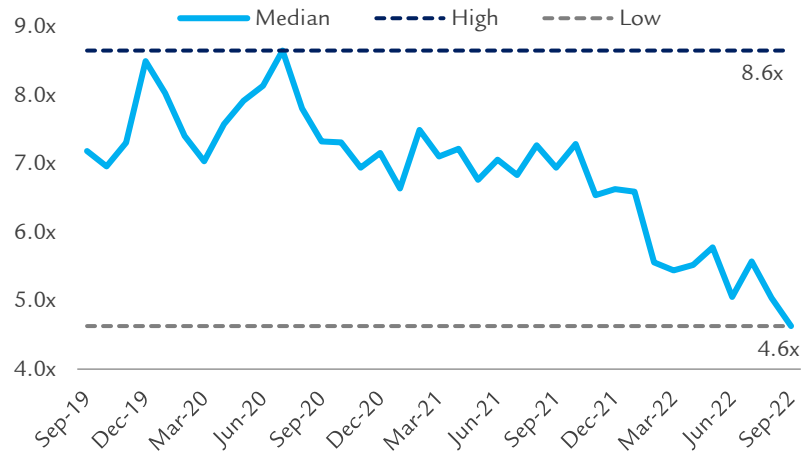
Payment 3-Yr Rolling Med. EV/LTM Revenue

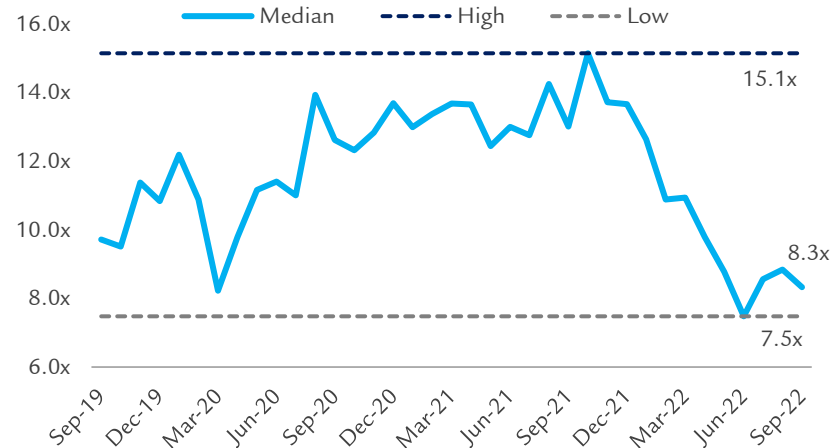

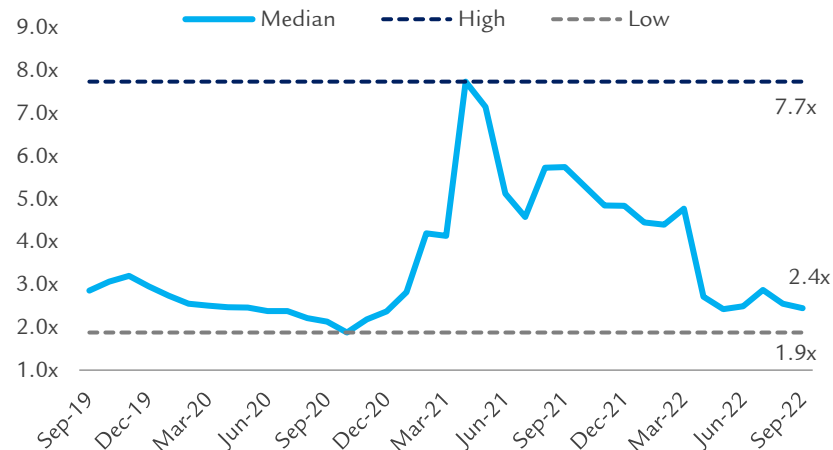
HCM 3-Yr Rolling Med. EV/LTM Revenue

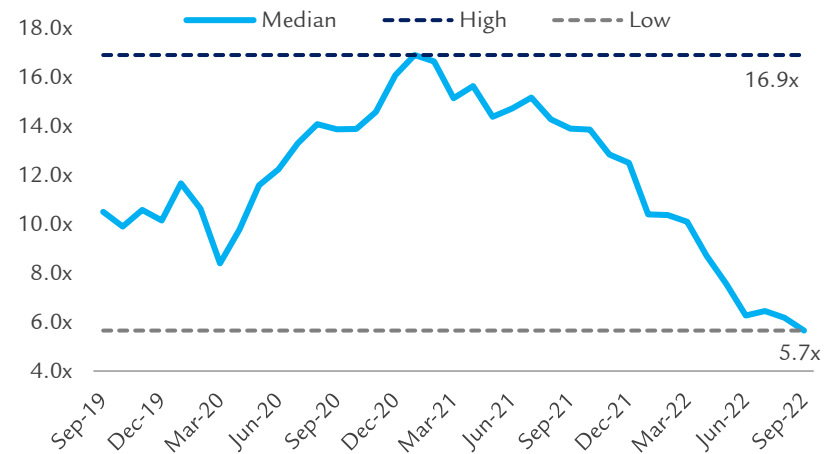

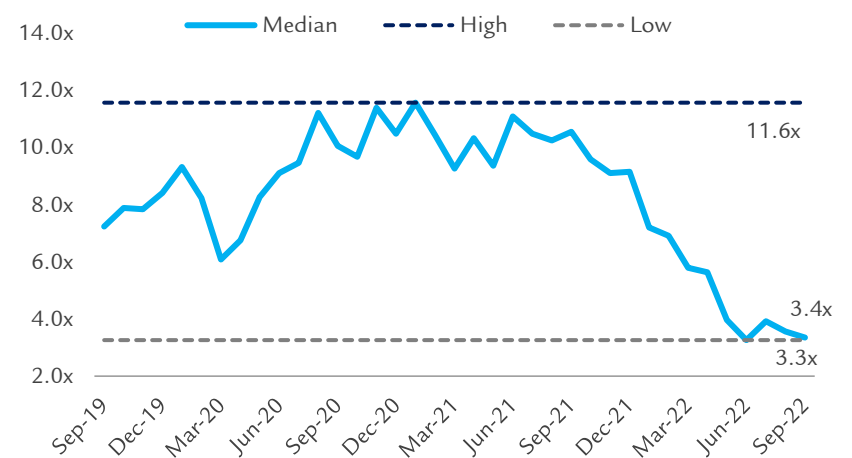
SaaS 3-Yr Rolling Med. EV/LTM Revenue

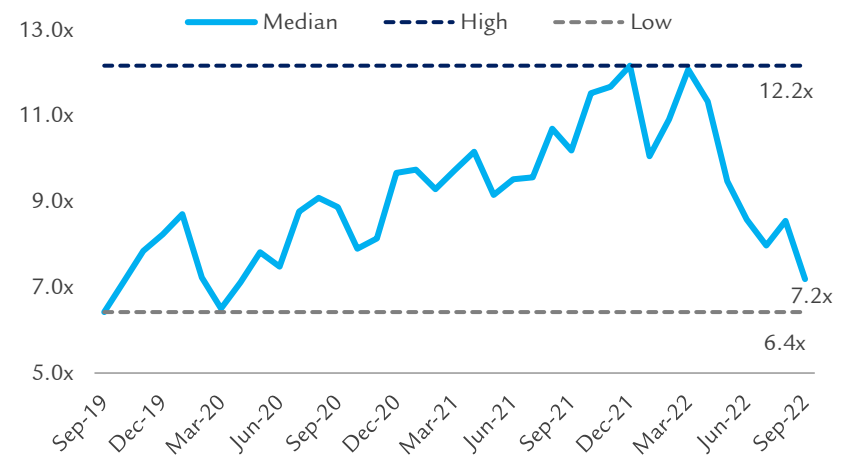

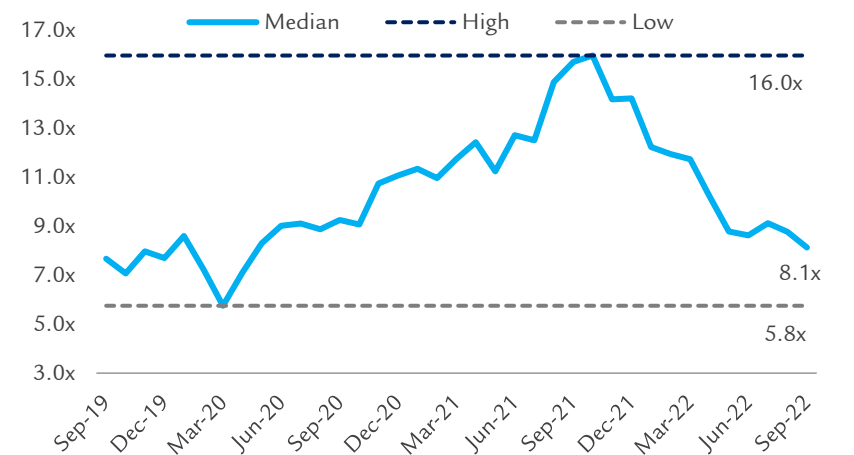
Security 3-Yr Rolling Med. EV/LTM Revenue

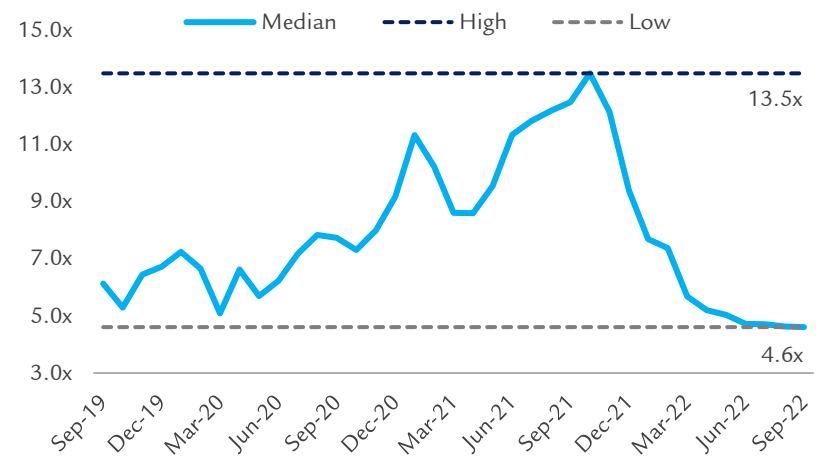

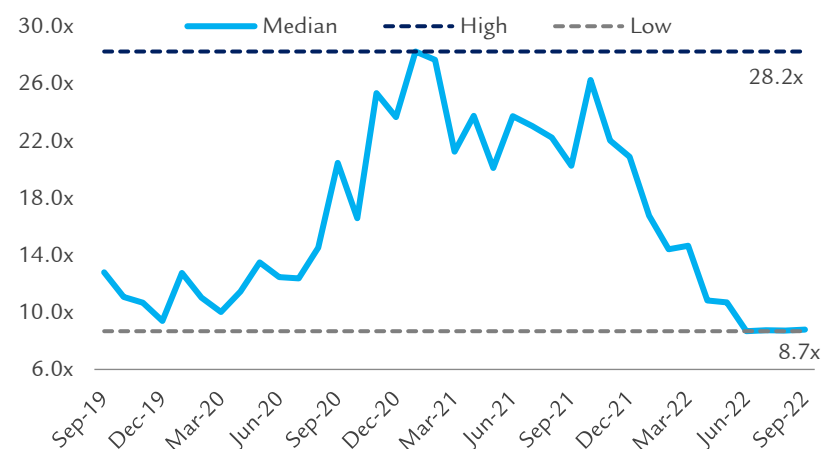
Vertical 3-Yr Rolling Med. EV/LTM Revenue

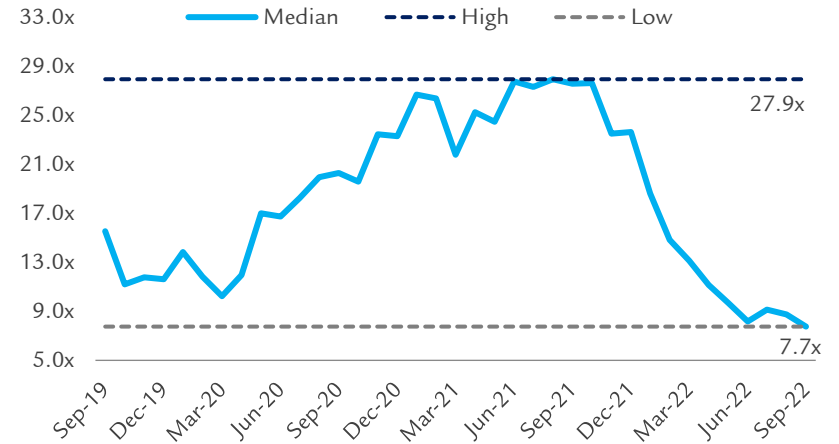

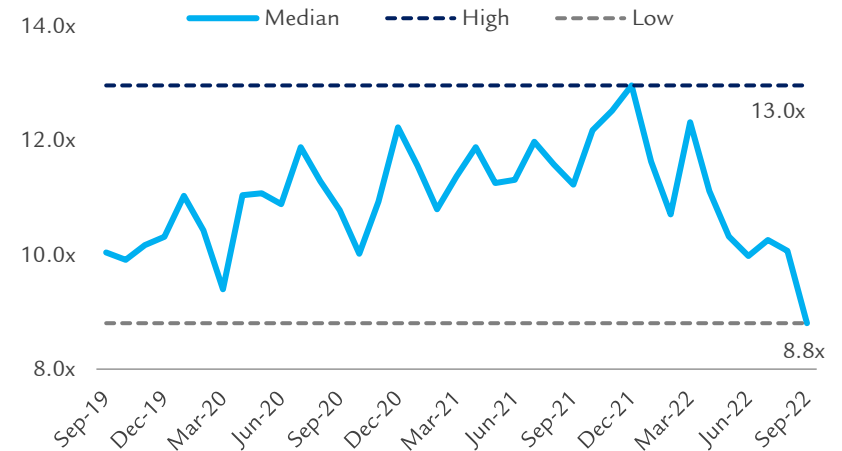
High Growth 3-Yr Rolling Med. EV/LTM Revenue

High Profitability 3-Yr Rolling Med. EV/LTM Revenue



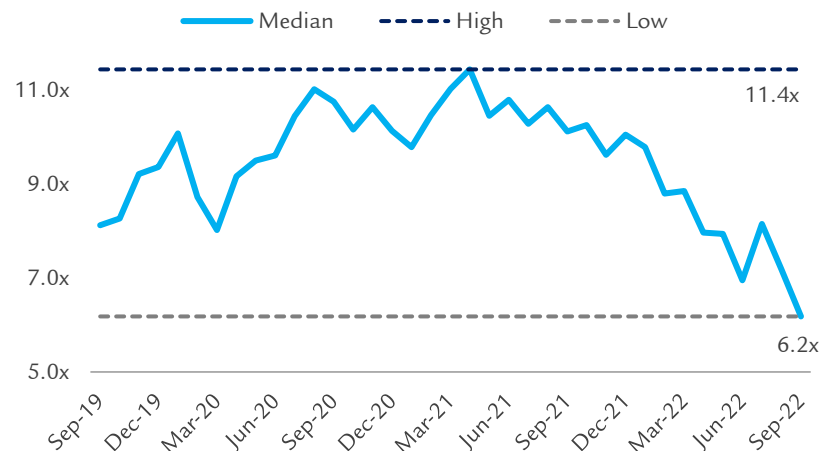

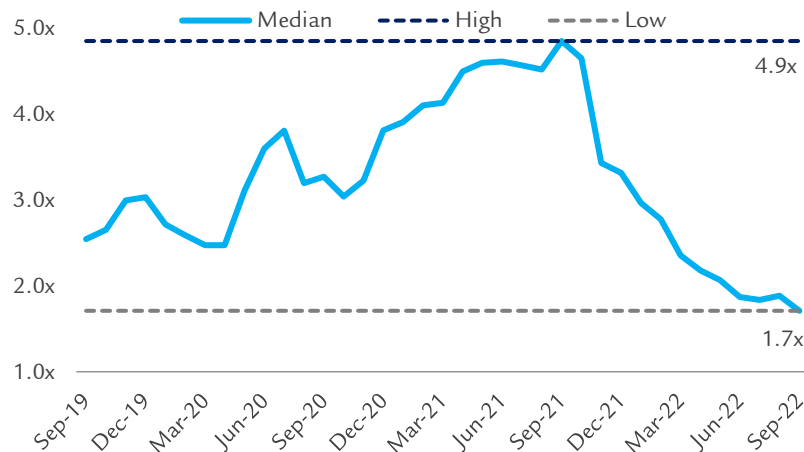
Large Cap 3-Yr Rolling Med. EV/LTM Revenue
